UK Elections Results

ELECTION COUNT COMPLETED

Election start date: Noon 2nd August 2021

Election end date: Noon 3rd August 2021

Voting Method: Approval Voting

Preamble

These elections used a type of voting system called 'approval voting', as requested by the NRNA UK Election Committee. Each voter could select (or 'approve') any number of candidates.

All candidate names are presented as they were provided by the NRNA Election Committee.

The winners of the elections are the candidates who were 'approved' by the largest number of votes.

Disclaimer

Please find our conclusions from the UK NRNA elections held from noon Monday 2nd August 2021 until noon Tuesday 3rd August 2021.

1. Elections for the UK President and Youth Coordinators

Modified opinion - Disclaimer: Kanto Elect has not been provided with enough information to determine whether or not these ballots were fair. An example of this is that Kanto Elect was not provided the process information of the election or proof that voters were eligible to vote.

Kanto Elect is not able to validate the email addresses provided and has not been able to confirm that each email address represents a separate person. Kanto Elect has checked that only the email addresses supplied by the Election Committee have voted on the online system. It has been verified that no voter email address other than those provided to Kanto Elect has been used for voting.

The email addresses that have been registered with the software were provided by the Election Committee, and verified true and accurate on Friday 30th July, 2021 at 2:39 PM by Mahendra Raj Kandel, the election chair, who confirmed that the data had been checked, verified as accurate and provided in good faith by the Election Committee. Neither Kanto Elect nor Choice Voting has any method of validating the accuracy of the membership data, as requested confirmations have not been provided, therefore Kanto Elect and Choice Voting relied solely on the data provided by the NRNA UK Election Committee.

Kanto Elect asked the Executive Committee and the Election Committee for clarification. They provided unanimous confirmation that they want Kanto Elect to publish the results. This letter is attached. The total number of disputed ballots is not larger than the majority of the presidential election.

Prior to the announcement of the results, Kanto Elect required the NRNA UK Election Committee and Executive Committee to confirm in writing the acceptance of the outcome of the election - and that no further discussions may be entered into.

The publication and announcement of results indicates that the Election Committee is in full approval, and has addressed any candidate concerns to its satisfaction prior to any announcement. The NRNA UK Election Committee certifies that all current obligations under the contract have been satisfied in full, and that all current or future obligations with Choice Voting and Kanto Elect will cease with immediate effect.

2. Elections for Central Committee Vice President (x2), Female Vice-President, Northern Ireland Regional Vice-President, Scotland Regional Vice-President, General Secretary, Secretary (x2), Female Secretary, Treasurer, Deputy Treasurer, Female Coordinator and Committee Members (x12)

Modified opinion – Adverse: the ballot DOES NOT give a fair view of the voters and has NOT been conducted to the standards stated in the documentation provided. We have not been provided proof that all voters are eligible voters.

Kanto Elect is not able to validate the email addresses provided and has not been able to confirm that each email address represents a separate person. Kanto Elect has checked that only the email addresses supplied by the Election Committee have voted on the online system. It has been verified that no voter email address other than those provided to Kanto Elect has been used for voting.

The email addresses that have been registered with the software were provided by the Election Committee, and verified true and accurate on Friday 30th July, 2021 at 2:39 PM by Mahendra Raj Kandel, the election chair, who confirmed that the data had been checked, verified as accurate and provided in good faith by the Election Committee. Prior to the announcement of the results, Kanto Elect required the NRNA UK Election Committee and Executive Committee to confirm in writing the acceptance of the outcome of the election - and that no further discussions may be entered into.

The publication and announcement of results indicates that the Election Committee is in full approval, and has addressed any candidate concerns to its satisfaction prior to any announcement. The NRNA UK Election Committee certifies that all current obligations under the contract have been satisfied in full, and that all current or future obligations with Choice Voting and Kanto Elect will cease with immediate effect.

Due to Kanto Elect being unable to receive confirmation from the NRNA of the authenticity of the eligible voters in the online election and evidence from members of likely suspicious behaviour in the election we are unable to support and validate the results of the ballot. Kanto Elect has not been provided proof by the NRNA of the eligible voters and has been given insufficient information to confirm that the election process was valid. **It is our opinion that the ballot DOES NOT give a fair view of the voters and has NOT been conducted to the standards required.**

The NRNA executive committee and election committee have accepted the adverse opinion. Prior to both committees accepting the adverse opinion and in light of the disputed eligible voter numbers, Kanto Elect provided the committees with the options available to them as potential next steps, including the option to rerun the election either in paper or digitally after doing a detailed membership review.

FAQ:

Why was the election start date delayed?

Kanto Elect was written to on Friday 30th July afternoon by the executive and election committees to request a delay in the start process to allow them more time to contact voters about the online process as NRNA had not yet emailed all members about the online process.

What was the role of Choice Voting?

Choice Voting is an online balloting company that was selected by the Election Committee of NRNA and performed an online ballot with the data set provided. The data set they were provided was signed off by the Election Committee and all voters on that data set were provided a vote if they had a valid email. Only email addresses on the data set voted.

What was the role of Kanto Elect?

Kanto Elect provided a helpdesk on election day for those people with ballot queries and was also asked to review the processes of the election and make sure that the ballot was run properly. Kanto Elect can confirm that the online process worked properly however there are people that had suspicious emails that voted in the election. These email addresses are suspicious due to their formatting, the IP address overlaps and the time and sequence of their logins.

Why did the election results take so long to publish?

It is usual to take up to 48 hours after the end of the election to look at patterns and trends of voter behaviour, including what time they login and the IP addresses they use. Upon seeing problematic trends of about 2,100 voters we have decided that this election result can not be trusted for the UK election.

Are the Votes included?

Yes, all the results are published including the votes that we think could be invalid at the request of the executive committee and election committee as seen in Appendix 1.

What is the problem?

The election data set was provided to Choice Voting by the NRNA Election Committee. All membership data was provided to the NRNA Election Committee by the NRNA UK Executive Committee. The NRNA UK Executive Committee obtained this data from the NRNA ICC (headquartered in Kathmandu), which stores this data. The Election Committee received this data on an Excel file from Kathmandu for the purposes of the election. This data was unchanged when it was provided to Choice Voting. After reviewing the voter patterns, Kanto Elect has been able to show there are problems with this provided data set, which the Election Committee and Executive Committee have accepted.

What should the next steps be?

An independent group should be selected to review the membership of NRNA and this should be done such that the data is collated in a usable GDPR compliant way. Then a new election could be created and managed with a new election management committee.

An adverse result is given for all votes in the UK election when the winning margin is less than the possible 2,132 suspect voters.
